The holder of the eGov-account is responsible for its use. If abusive or fraudulent conduct of the digital identity holder or third parties is detected, the account will be suspended immediately.

The eGov-account login credentials (username and password or Service Card and PIN) are strictly personal and should be kept with the utmost confidentiality and diligence, and also should not be given to third parties in any capacity (not even to the call center!).
